#### 1 PURPOSE

GasMeth Energy Ltd invites tenders from suitably qualified and experienced contractors for the civil works construction of interim offices and a gatehouse building at Karongi CNG project. This ITT provides all the information required to prepare and submit a compliant tender.

#### 2 SCOPE OF WORK

The Owner shall be under no obligation to supply such utilities during such periods; provided that the Owner shall use its reasonable efforts to support Contractor in obtaining such utilities as Contractor reasonably requires.

#### 3 GENERAL REQUIREMENTS/ BID INFORMATION

Contractors are invited to bid and quote prices bearing the following in mind:

#### 3.1 Technical

- Bidder shall possess experience in undertaking similar Works in accomplished projects in the past 5 years.
- Availability of equipment/machines to be guaranteed such as excavators with bucket and jackhammer, wheel loaders, bulldozers, compactors. dump trucks with capacity to excavate in rocky areas that there will be no delay or hold-up in operations.

- In case the bidder intends to subcontract, the total of the proposed subcontracted parts shall not represent more than 75 % of the amount of the Total Tender Sum.

- "Sub-subcontracting" shall not be allowed without Gasmeth's prior written approval.

#### 3.2 Commercial

- The bidders should have positive net worth as per the latest audited financial statement. However, bidders having negative net worth will also be considered, provided all their annual reports for last three financial years indicate profit after tax. Bidder shall furnish annual report/ audited balance sheets including profit and loss accounts along with the bid to establish bidder's conformance to qualification criteria.
- Bidder shall not be under liquidation, court receivership or similar proceeding. (Undertaking to this effect to be submitted by the bidder)
- The contractors shall submit a quotation, and the type of contract will be on measurement basis.
