Partners In Health / Inshuti Mu Buzima is seeking for proposals from qualified and authorized suppliers / vendors for the tender related to supply of maintenance kits, spare parts, and maintenance services for GE anesthesia Machine ; ORICARE anesthesia machine and biosafety cabinets under framework agreement.

Interested, qualified and authorized bidders should provide their proposals bearing the following tendering requirements:

**1. Compulsory requirements**

- Vendor must submit valid license to operate pharmacy services issued by Rwanda FDA
- Not being under blacklisted vendor list by Rwanda Public Procurement Authority (RPPA) nor Partners In Health

**2. Administrative requirements**

- Proof of Business registration (RDB certificate) in respective domain
- Valid RRA tax clearance or proof of RRA certificate request in process
- Bidders should submit a copy of VAT registration certificate where it is applicable.

### 3. Technical requirements:

- Validity of offers shall not be less than 120 calendar days from the day of its submissions to PIH.
