1. Introduction and Objective

Ecofleet Solutions Ltd is mandated to modernize and enhance public transport services within the City of Kigali through efficient and reliable fleet management. As part of its commitment to maintaining high service standards and ensuring safe, dependable, and commuter-friendly transport, Ecofleet requires a consistent and reliable supply of quality spare parts to support its bus operations.

To sustain optimal performance and availability of its fleet of **190 ZK6106HG Yutong buses**, Ecofleet Solutions Ltd intends to engage qualified and experienced suppliers for the supply of genuine and compatible spare parts. The objective of this tender is to select competent suppliers capable of providing timely, high-quality spare parts to support preventive and corrective maintenance, thereby ensuring continuous, safe, and efficient fleet operations.

2. Scope of Supply

This is a **goods supply contract** for the provision of spare parts, consumables, oils, lubricants, fluids, and batteries required for the maintenance and operation of Ecofleet's fleet of **190 ZK6106HG Yutong buses**.

The procurement is structured into **separate lots** to increase competition, transparency, and supplier specialization. Bidders may apply for **one or more lots**. Contracts shall be awarded per lot based on compliance and evaluated responsiveness.

LOT 1: ENGINE & POWERTRAIN SPARE PARTS

Scope includes:

- Engine internal components
(pistons, piston rings, cylinder liners, crankshaft, camshaft, bearings)
- Engine sealing components
(gaskets, oil seals, O-rings)
- Fuel supply & injection system
(fuel pumps, injectors, fuel rails, fuel filters)
- Air intake system
(turbocharger, intercooler hoses, intake manifolds)
- Lubrication system
(oil pumps, oil coolers)
- Cooling system
(radiators, thermostats, water pumps, cooling fans)
- Exhaust & emission system
(exhaust manifolds, silencers, sensors, EGR components)
- Transmission & driveline
(clutch kits, pressure plates, gearbox components, propeller shafts, universal joints)

Quality Requirements:

- OEM or OEM-approved equivalent
- Minimum 6 months warranty or manufacturer warranty (whichever is longer)

LOT 2: BRAKE, SUSPENSION & STEERING SYSTEMS

Scope includes:

- Brake system (brake pads, brake shoes, brake discs, brake drums, calipers)
- Pneumatic braking components (air compressors, air dryers, brake chambers, valves)
- Suspension system (leaf springs, air suspension bellows, shock absorbers, bushings)
- Axles & wheel-end components (wheel hubs, bearings)
- Steering system (steering gearboxes, tie rods, drag links, power steering pumps)

Quality Requirements:

- OEM or equivalent
- Compliance with bus safety standards

LOT 3: ELECTRICAL & ELECTRONIC SYSTEMS

Scope includes:

- Power generation & starting (alternators, starters, voltage regulators)
- Electronic control units (ECUs, control modules)
- Sensors (speed, pressure, temperature, ABS sensors)
- Wiring & connectors (wiring harnesses, terminals, relays, fuses)
- Lighting systems (headlamps, rear lamps, indicators, interior lights)
- Instrumentation & driver interface (instrument clusters, switches, horns)
- Wiper & washer systems

Quality Requirements:

- OEM or certified equivalent
- Electrical compatibility with 24V bus system
- Minimum 6 months warranty

LOT 4: BODY, INTERIOR & SAFETY COMPONENTS

Scope includes:

- Body panels & exterior fittings (mirrors, bumpers, doors, hinges)
- Door operating systems (pneumatic/electric door actuators)
- Interior fittings (passenger seats, handrails, flooring materials)
- Safety equipment (fire extinguishers, emergency hammers, safety signage)
- Glass & rubber fittings (windscreens, window seals)

Quality Requirements:

- OEM or approved equivalent
- UV, vibration, and impact resistance
- Minimum 6 months warranty

LOT 5: FILTERS & ROUTINE CONSUMABLES

Scope includes:

- Oil filters
- Fuel filters
- Air filters
- Cabin filters
- Hydraulic & pneumatic filters
- Separator filters

Quality Requirements:

- OEM or equivalent
- Exact match to engine and system specifications
- Minimum 3 months warranty

LOT 6: OILS, LUBRICANTS & FLUIDS

Scope includes:

- Engine oils (manufacturer-recommended grades)
- Gearbox & differential oils
- Hydraulic oils
- Brake fluids (DOT specifications)
- Coolants / antifreeze
- Power steering fluids
- Greases

Quality Requirements:

- Compliance with OEM specifications
- RSB / API / SAE / ISO standards
- MSDS required
- Minimum shelf life: 18 months

LOT 7: TYRES, BATTERIES & RUBBER PARTS

Scope includes:



- Bus tyres (front & rear axle specifications)
- Inner tubes (if applicable)
- Vehicle batteries (12V / 24V heavy-duty)
- Rubber components (hoses, mounts, seals, bushings)
- Battery accessories (terminals, clamps)

Quality Requirements:

- Heavy-duty bus application compliance
- Tyres compliant with axle load ratings
- Batteries with minimum 12 months warranty
- International standards (DIN, JIS, or equivalent)

3. General Supply Requirements (All Lots)

a) Delivery Terms

- Delivery to Ecofleet depots within Kigali
- Delivery timeframe: Urgent orders within 24-48 hours, regular orders within 4 working days
- Emergency supply capability for critical parts
- Proper packaging to prevent damage during transport
- Delivery notes and invoices must accompany all deliveries

b) Quality Assurance

- All parts must be new and unused
- Genuine or approved equivalent parts only
- Certificate of conformity for each delivery
- Right to reject non-conforming items

c) Warranty and After-Sales Support

- Warranty as specified per lot
- Free replacement of defective parts within warranty period

c) Parts Catalog and Inventory Management

- Comprehensive parts catalog with cross-references
- Electronic ordering system (preferred)
- Real-time inventory visibility
- Quarterly stock review meetings

5. Financial and Commercial Terms

- b) **Commercial Terms (15%)**
 - Payment terms

 - Discounts and rebates
 - Price stability mechanisms
